*Commencement : 1st November, 1961*

In exercise of the powers conferred by section 5 of the Prisons Ordinance, 1960, the Minister of Internal Affairs as the Minister of the Federation charged with responsibility for matters relating to prisons has made the following order:—

1. This Order may be cited as the Kirikiri Prison Appropriation (Female Prisoners) Order, 1961, and shall have effect from the 1st day of November, 1961.
