# MINERALS ACT (CAP. 121) 

Prospecting (Areas and Minerals) Prohibition Declaration, 1962

Commencement : 14th fyune, 1962
In exercise of the powers conferred by section 8 of the Minerals Act, the Minister of Mines and Power of the Federation has made the following declaration-

1. This declaration may be cited as the Prospecting (Areas and Minerals) Prohibition Amendment (No. 4) Declaration, 1962, and shall apply throughout the Federation.
2. Immediately after paragraph 30 of the Prospecting (Areas and Minerals) Prohibition Declaration, 1946, there shall be inserted the following new paragraphs :-
"31. The following area is hereby declared to be closed to prospecting for all minerals :-

All that parcel of land known as Mines Reclamation Area No. 33 in Jos Division of Plateau Province containing an area of approximately 28.34 acres, the boundaries of which are as below.

Starting at a concrete pillar marked P.B. 8995 also CB 3 of M.L. 7510 which lies on a bearing of $18^{\circ} 16^{\prime}$ at a distance of approximately 372.2 feet from P.B. 9002, the boundaries run in straight lines, the bearings and lengths of which are as follows :-
