## THE IMMIGRATION ACT, CHAPTER 84

## Prohibition of Paul Henri Edouard Lauwers from entering Nigeria

WHEREAS the Federal Minister responsible for immigration is satisfied that the person named hereunder is an undesirable person and is not a Nigerian Citizen, it is expedient that his immigration into Nigeria by any means be prohibited :

Notice is accordingly hereby given under the Immigration Act that PAUL HENRI EDOUARD LAUWERS is hereby declared to be a prohibited immigrant in respect of entry into Nigeria and the provisions of the Immigration Act shall have effect accordingly.

CUSTOMS AND EXCISE MANAGEMENT ORDINANCE, 1958

Open General Import Licence (Sugar) No. 6 of 1959

**EXPORT OF NIGERIAN PRODUCE ACT, 1958**  
(No. 36 of 1958)

**Export of Nigerian Produce (Prescribed Grades and Standards)  
(Amendment) Regulations, 1962**

*Commencement : 30th August, 1962*

In exercise of the powers conferred by sections 3 (a) and 8 (d) of the Export of Nigerian Produce Act, 1958, the Federal Minister of Commerce and Industry, after consulting with and obtaining the advice of the Nigerian Produce Marketing Company Limited, the Produce Inspection Board and the Regional Marketing Boards, has made the following regulations—

Citation and application.

1. These regulations may be cited as the Export of Nigerian Produce (Prescribed Grades and Standards) (Amendment) Regulations, 1962, and shall be of Federal application.

Amendment of regulation 2. L.N. 230 of 1959.

2. Regulation 2 of the Export of Nigerian Produce (Prescribed Grades and Standards) Regulations, 1959 (hereinafter referred to as the principal regulations) is hereby amended in so far as cocoa is concerned, by deleting the existing prescriptions in respect of both grades and substituting the following—

Cocoa.

The grades shall be—

Grade I—Cocoa which is thoroughly dry, free from foreign matter and from smoky, velvety or black beans and any evidence of adulteration, and which contains less than—

- (a) 3 per cent by count of mouldy beans ;
- (b) 3 per cent by count of slaty beans ; and
- (c) 3 per cent by count of all other defects.

Grade II—Cocoa which does not qualify for grade I but which is thoroughly dry, free from foreign matter and from smoky, velvety or black beans and any evidence of adulteration and which contains less than—

- (a) 4 per cent by count of mouldy beans,
- (b) 8 per cent by count of slaty beans ; and
- (c) 6 per cent by count of all other defects.
