**IMMIGRATION ORDINANCE (CHAPTER 84)**  
(REVISED EDITION)

**The Anerthey Abbey Deportation Order, 1962**

WHEREAS on the 13th day of July, 1962, before the Magistrate's Court of Kaduna ANERTEY ABBEY was charged with offences contrary to subsection (1) of section 15 and subsection (2) (a) of section 12 of the Immigration Ordinance (Cap. 84), and was convicted by the said Court;

AND WHEREAS the said court in exercise of the powers conferred by subsection (1) of section 16 of the said Ordinance has reported the case of the said ANERTEY ABBEY to me;

AND WHEREAS I, USMAN SARKI, Federal Minister of Internal Affairs have considered the continuing position of the said ANERTEY ABBEY in Nigeria and have deemed it fit to make a deportation order;

NOW THEREFORE, in exercise of the powers conferred upon me by subsection (2) of section 16 of the Immigration Ordinance (Cap. 84), as amended by the Transfer of Functions (Federation) Order 1959 (Legal Notice 258 of 1959), it is hereby ordered that the said ANERTEY ABBEY shall leave Nigeria on the first available opportunity and remain thereafter out of Nigeria.

**EXCHANGE CONTROL ACT, 1962**

## MINERALS ACT (CAP. 121)

Prospecting (Areas and Minerals) Prohibition  
(Amendment) (No. 5) Declaration, 1962

Commencement : 11th October, 1962

In exercise of the powers conferred by section 8 of the Minerals Act, the Minister of Mines and Power of the Federation has made the following declaration—

Citation.

1. This declaration may be cited as the Prospecting (Areas and Minerals) Prohibition (Amendment) (No. 5) Declaration, 1962, and shall apply throughout the Federation.

2. Immediately after paragraph 32 of the Prospecting (Areas and Minerals) Prohibition Declaration, 1946, there shall be inserted the following new paragraphs :—

“33. The following area is hereby declared to be closed to prospecting for all minerals :—

2. All that parcel of land known as Mines Reclamation Area No. 35 (which is composed of late MLL.1434 and 1435) in the Ron and Gashish Districts of Plateau Province, containing an area of approximately 65.65 acres, the boundaries of which are described below.

3. Starting at a concrete pillar, marked PBP.9250 (Also CB2 of ML.11687) the Colony Co-ordinates of which are N. 1,958,083 feet ; E. 2,346,295 feet ; the boundaries run in straight lines, the bearings and lengths of which are as follows :—

## LAGOS LOCAL GOVERNMENT ACT, 1959

### Lagos Local Government (Amendment) Bye-Laws, 1962

*Commencement : 11th October, 1962*

In exercise of the powers conferred by sections 143 and 144 of the Lagos Local Government Act, 1959, the Lagos Town Council, with the approval of the Governor-General-in-Council, has made the following bye-laws.

1. These bye-laws may be cited as the Lagos Local Government (Amendment) Bye-Laws, 1962.

Short title.

2. In paragraph (1) of bye-law twenty-seven of the Lagos Local Government Bye-Laws (which provides that the percentage of the area of site which a dwelling-house and other houses may occupy is not to exceed fifty per cent) for the words "fifty per cent" there shall be substituted the words "seventy-five per cent".

Increase of percentage of site to be built upon.
