IMMIGRATION ACT (CHAPTER 84)

Prohibition of William John Morley from entering Nigeria

WHEREAS as provided for under paragraph (c) of subsection (2) of section 12 of the Immigration Act, WILLIAM JOHN MORLEY is deemed, from official Government records, to be an undesirable person :

NOW, THEREFORE, under the provisions of the said section 12, the immigration into Nigeria of the said WILLIAM JOHN MORLEY is prohibited accordingly.

MERCHANT SHIPPING ACT, 1962

(1962 No. 30)

Merchant Shipping (Ports Authority Partial Exemption) Notice, 1963

In exercise of the powers conferred by Section 424 of the Merchant Shipping Act, 1962, and of all other powers enabling him in that behalf the Minister of Transport has exempted any ship owned or operated by the Nigerian Ports Authority and the master and crew of any such ship from the following provisions of the Merchant Shipping Act, 1962—

The provisions relating to :—

- (a) the exemption from stamp duty and record of indentures of apprenticeship, and matters to be done for the purpose of such record ;
- (b) agreements with the crew (except the provisions relating to the engagement of a seaman abroad) ;
- (c) the entry in the agreement with the crew of the particulars respecting apprentices and matters to be done for the purpose of such entry ;
- (d) the compulsory discharge and payment of seamen's wages before a superintendent and the compulsory delivery of an account of wages ;
- (e) the accommodation of seamen ;
- (f) the deduction and payment of fines imposed under stipulations in the agreement ;
- (g) the delivery of documents at ports outside Nigeria to proper officers ;
- (h) official log books.

This exemption shall take effect from the 1st of April, 1963.

MERCHANT SHIPPING ACT, 1962

Merchant Shipping (Restricted Commencement) Notice, 1963

In exercise of the powers conferred by subsection (2) of Section 1 of the Merchant Shipping Act, 1962, and of all other powers enabling him in that behalf the Minister of Transport has appointed the 1st day of April, 1963, as the date on which the following provision of the Merchant Shipping Act, 1962 shall come into operation—

Parts II, III, IV (excluding Section 145 thereof), V, VI, VII, VIII, X, XI (excluding subsection (6) of Section 383 thereof) XII and XIII.

MERCHANT SHIPPING ACT, 1962
(1962, No. 30)

Merchant Shipping (Inland Waters Craft Exemption) Notice, 1963

In exercise of the powers conferred by Section 424 of the Merchant Shipping Act, 1962 and of all other powers enabling him in that behalf the Minister of Transport has exempted vessels which are employed solely in the navigation of the Inland Waters of Nigeria from the following provisions of the Merchant Shipping Act, 1962—

- (1) *Part III* : Chapters 5-18 ; Chapter 19 (Sections 112-127) ; and Chapters 20-23 ;
and
- (2) *Part XII* : Chapter 86.

This exemption shall take effect from the 1st day of April, 1963.
