MERCHANT SHIPPING ACT, 1962
(1962, No. 30)

Merchant Shipping (Subsidiary Legislation Transitional
Provisions) Order, 1963

Commencement: 1st April, 1963

In exercise of the powers conferred by Section 433 of the Merchant Shipping Act, 1962, and of all other powers enabling me in that behalf, I hereby make the following Order :—

1. This Order may be cited as the Merchant Shipping (Subsidiary Legislation Transitional Provisions) Order, 1963.

Citation.

2. Until such time as various Rules and Regulations which are required to be made under the Merchant Shipping Act, 1962 are in fact made, the following Subsidiary Legislation hitherto in force under the Shipping and Navigation Act, now repealed, shall continue to be in force until superseded by Subsidiary Legislation made under the Merchant Shipping Act, 1962—

- (a) Certificates of Competency Regulations, 1959.
- (b) Navigation of Inland Waters Regulations, 1959.
- (c) Power Driven Small Craft Regulations, 1959.
- (d) Shipping and Navigation (Licensing of Boats) Regulations.
- (e) Survey of Vessels (General) Regulations, 1959.
- (f) Survey of Vessels (Sea-going) Regulations, 1959.
- (g) Survey of Vessels (Inland Waters) Regulations, 1959.

EXPLANATORY NOTE

These transitional provisions are to ensure that there is proper control over the survey of vessels and the examination of certificated personnel during the interim period between the Merchant Shipping Act coming into force and the Subsidiary Legislation being published.

ANTIQUITIES ORDINANCE (CHAPTER 12)

Antiquities (Monuments) Declaration Notice, 1961

Commencement : 19th March, 1963

WHEREAS the Antiquities Commission has submitted an application in accordance with subsection (4) of section 14 of the Antiquities Ordinance (Chapter 12) (hereinafter referred to as the Ordinance) for the declaration as monuments of the antiquities as set forth in the Schedule to this notice :

AND WHEREAS the application has been considered by the Governor-General in Council :

NOW THEREFORE in exercise of the powers conferred by subsection (5) of section 14 of the Ordinance the Governor-General acting in accordance with the advice of the Council of Ministers, hereby gives the following notice—

1. This notice may be cited as the Antiquities (Monuments) Declaration Notice, 1963.
2. The antiquities set forth in the Schedule to this notice are declared to be monuments.
