IMMIGRATION ACT, 1963

Prohibition of Khalid Nasserdeen alias Levi Sloane from entering Nigeria

WHEREAS as provided for under subsection (2) of section 17 of the Immigration Act, 1963, the Minister of Internal Affairs has deemed it conducive to public good to prohibit the entry into Nigeria of Khalid Nasserdeen *alias* Levi Sloane, born in Harrisburg, United States of America, on 11th day of April, 1930.

NOW, THEREFORE, under the provision of the said section seventeen of the Immigration Act, 1963, the immigration into Nigeria of the said Khalid Nasserdeen *alias* Levi Sloane is prohibited accordingly.

Open General Import Licence (Sugar) No. 6 of 1959

EXPLANATORY NOTE

The effect of this amendment is that specific import licences are no longer required for the importation of goods from Hungary and U.S.S.R. All imports originating in both countries are now subject to the terms of the Open General Import Licence (Scheduled Territories and Easy Currency Countries) No. 2 of 1959.
