## FIREARMS ACT (CHAPTER 69)

### Firearms Prohibition (Eastern Nigeria) Order, 1965

*Commencement : 9th January, 1965*

In exercise of the powers conferred by section 36 of the Firearms Act and all other powers enabling me in that behalf, I hereby make the following Order :—

Citation and  
Application.

1. This Order may be cited as Firearms Prohibition (Eastern Nigeria) Order, 1965 and shall apply to Eastern Nigeria.

Prohibition.

2. The possession of or dealing in any firearms or ammunition in the Okrika Local Council area in Eastern Nigeria, is hereby absolutely prohibited for a period of six months from the date of publication of this Order in the *Federation of Nigeria Official Gazette*.

Surrender.

3. All firearms and ammunition in possession of any person within the area specified in the foregoing section 2 of this Order shall be surrendered to the Assistant Commissioner of Police, Port Harcourt within seven days from the date of the publication of this Order.

4. Any person neglecting to make such surrender or being in possession of or dealing in any firearms or ammunition during the period that this Order is in force, shall be guilty of an offence and shall be liable on conviction to a penalty of five hundred pounds or imprisonment for two years or to both such fine and imprisonment. Penalty.
