MERCHANT SHIPPING ACT 1962  
(1962 No. 30)

Merchant Shipping (Fees) (Amendment) Regulations 1965

*Commencement : 1st April 1965*

In exercise of the powers conferred by section 427 of the Merchant Shipping Act 1962 and of all other powers enabling me in that behalf, I hereby make the following Regulations :—

1. These Regulations may be cited as the Merchant Shipping (Fees) (Amendment) Regulations 1965 and shall apply throughout the Federation.

2. The Merchant Shipping (Fees) Regulations 1965 hereinafter referred to as the "principal regulations" is amended as follows—

(i) Delete the year "1964" and substitute "1965" in regulation 1 of the principal regulations.

(ii) In paragraph 12 (d) of Part XII of the principal regulations, substitute the fee of "7s-6d." for "17s-6d." where it occurs.

(iii) Insert the following new paragraph after paragraph (b) of Part XVII of the principal regulations—

"(c) For the inspection and re-certification of an inflatable liferaft, except where it is surveyed as part of a full l.s.a survey. 15s-9d"
