LABOUR CODE ACT (CHAPTER 91)

The Labour Code (Trade Union Contributions) Order, 1965

Commencement: 1st May, 1965

In exercise of the powers conferred by section 27A (2) of the Labour Code Act, I hereby make the following Order—

- 1. This Order may be cited as the Labour Code (Trade Union Contributions) Order, 1965 and shall apply throughout the Federation.
- 2. The Trade Union specified in the first column of the Schedule is hereby approved for the purpose of section 27A (1) of the Labour Code Act with effect from the date specified in the second column of the schedule.

POLICE ACT (CHAPTER 154)

Police (Amendment) Regulations, 1965

Commencement: 1st January, 1965

In exercise of the powers conferred on me by section 47 of the Police Act, and of all other powers enabling me in that behalf, I hereby, on the recommendation of the Nigeria Police Council, make the following regulations—

- 1. These regulations may be cited as the Police (Amendment) Regulations, 1965, and shall apply throughout the Federation.
- 2. Paragraph (1) of regulation 5 of the Police Regulations, 1959 (hereinafter referred to as "the principal regulations") is amended—
 - (a) by the deletion of the words "Senior Superintendents" and the substitution therefor of the following—

"Chief Superintendents"

Citation and application, Amendment of Regulation 5 (1). (b) by the addition after the words "Assistant Superintendents" of the following—

"Cadet Assistant Superintendents"

Amendment of Regulation 10 (1). 3. Paragraph (1) of regulation 10 of the principal regulations is amended by the deletion therefrom of the words "Senior Inspectors"

Amendment of Regulation 15 (1). 4. Paragraph (1) of regulation 15 of the principal regulations is amended by the deletion therefrom of the following—

"Sergents-Major" and

"Lance-Corporals"

Amendment of Regulation 16 (1).

- 5. Paragraph (1) of regulation 16 of the principal regulations is amended—
- (i) by the deletion therefrom of the whole of sub-paragraph (a) and the letter 'b';
- (ii) by the insertion of the word "and" between the words "Corporal and Sergeant".

Amendment of Regulation 27 (1). 6. Paragraph (1) of regulation 27 of the principal regulations is amended by the deletion from sub-paragraph (b) (ii) of the following—

"Sergeant-Major or"

Amendment of Regulation 31.

- 7. Regulation 31 of the principal regulations is amended by the deletion of—
 - (i) the words "Lance-Corporal" appearing in the second line;
 - (ii) the words "Sergeant-Major" appearing in the third line.

Amendment of Regulation 33 (1). 8. Paragraph (1) of regulation 33 of the principal regulations is amended by the deletion of the words "Sergeant-Major" and the substitution thereof of the following—

"Sergeant"

Amendment of Third and Fourth Schedules. 9. The Third and Fourth Schedules to the principal regulations are amended by the deletion of the words "Senior Superintendents" wherever they occur and the substitution therefor of the following—

"Chief Superintendents"
