STATE SECURITY (DETENTION OF PERSONS) (RESTRICTED REVOCATION) DECREE 1966



Decree No. 53

[Section 2(2)]

Commencement.

THE NATIONAL MILITARY GOVERNMENT hereby decrees as follows:—

- 1.—(1) The persons named in Schedule 1 to this Decree shall cease to be detained.
- (2) Accordingly the Decrees mentioned in Schedule 2 shall be revoked to the extent therein set forth, so however that references to detention of persons, however worded in the State Security (Detention of Persons) Decree 1966, shall be construed as applicable to persons held under detention decrees not hereby revoked.

Provision for release of certain detained persons.

1966 No. 3.

- 2.—(1) This Decree may be cited as the State Security (Detention of Persons) (Restricted Revocation) Decree 1966.
- (2) This Decree shall be so construed as to validate the release of any persons named herein who ceased to be detained before the date hereof.
