TRIBUNALS OF INQUIRY DECREE 1966
(1966 No. 41)

**Lagos Executive Development Board Tribunal of Inquiry
(Amendment) Order 1967**

In exercise of the powers conferred by section 2 of the Tribunals of Inquiry Decree 1966 I, Lieutenant-Colonel Yakubu Gowon, Head of the Federal Military Government, Supreme Commander of the Armed Forces, hereby make the following Order :

Reconstitution of Tribunal, and new date for first meeting.

1.—(1) The appointment of Mr Justice A. O. Obaseki as a member of the Lagos Executive Development Board Tribunal of Inquiry is hereby terminated.

(2) Mr M. N. Q. Sagoe shall be the Chairman of the said Tribunal in place of Mr Justice A. O. Obaseki.

(3) Mallam A. K. Oba is hereby appointed to be a member of the said Tribunal.

(4) The Tribunal (which has not yet met) shall hold its first meeting in Lagos on 11th January 1967.

(5) Accordingly the Instrument constituting the said Tribunal is hereby amended as follows—

L.N. 114 of 1966.

(a) the words "Mr Justice A. O. Obaseki", where they first occur, shall be omitted ;

(b) Beneath the words "Mr E. E. Nsefik" there shall be inserted the words "Mallam A. K. Oba" ;

(c) for the words "Mr Justice A. O. Obaseki aforesaid" there shall be substituted the words "Mr M. N. Q. Sagoe aforesaid" ; and

(d) for the words "12th December 1966" there shall be substituted the words "11th January 1967".

Citation.

2. This Order may be cited as the Lagos Executive Development Board Tribunal of Inquiry (Amendment) Order 1967.
