The State Security (Detention of Persons) (No. 4) Order 1967

Commencement : 24th January 1967

In exercise of the powers conferred by section 3 (g) of the State Security (Detention of Persons) Decree 1966 as inserted by section 1 of the State Security (Detention of Persons) (Amendment) Decree 1966, and of all other powers enabling the Council in that behalf, the Supreme Military Council hereby makes the following order :—
