### COMPANIES INCOME TAX ACT 1961 (1961 No. 22)

## Companies Income Tax (Exemption) (Export-Import-Bank of Washington) Order 1967

Commencement: 28th February 1964

In exercise of the powers conferred by section 26 (2) of the Companies Income Tax Act 1961, as amended by the Constitution (Suspension and Modification) Decrees (Nos. 1—10), and of all other powers enabling it in that behalf, the Federal Executive Council hereby makes the following Order:—

1.—(1) This Order may be cited as the Companies Income Tax (Exemption) (Export-Import Bank of Washington) Order 1967 and shall be deemed to have come into effect from the 28th February 1964.

Citation, commencement and extent.

- (2) This Order shall apply throughout Nigeria.
- 2. The Company known as the Export-Import Bank of Washington, whose address is Washington D.C. United States of America (hereinafter referred to as "the Company") is hereby exempted from the provisions of the Companies Income Tax Act 1961, in respect of interest derived by the Company from money lent by it to the Aba Textile Mills Limited and evidenced by an agreement dated 28th February 1964, made between the Company and the Aba Textile Mills Limited.

Company and income exempted.

3. The exemption shall continue in force for so long as the Company does not become a Nigerian company as defined in section 2 of the Companies Income Tax Act 1961.

Duration of exemption.

#### EXPLANATORY NOTE

This Order makes provision for the income tax exemption authorised to be made in respect of any interest derived by the Export-Import Bank of Washington from money lent by it to the Aba Textile Mills Limited (for financing the purchase of spinning and weaving equipment and machinery for the manufacture of cotton cloth etc.) and evidenced by an agreement dated 28th February 1964, made between the Company and the Aba Textile Mills Limited.
