

THE APPROPRIATION DECREE, 1967



Decree No. 9

[1st April 1967]

Commencement.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows:—

1.—(1) The Accountant-General may, when authorised so to do by warrants issued by the Supreme Military Council, pay out of the Consolidated Revenue Fund during the year ending 31st March 1968 the sum specified by warrants, not exceeding in the aggregate sixty-eight million, four hundred and eighty-four thousand, and seventy pounds.

Issue and Appropriation of £68,484,070 from Consolidated Revenue Fund for 1967-68.

(2) The amount mentioned in the foregoing subsection shall be appropriated to heads of expenditure as indicated in the Schedule of this Decree.

(3) No part of the amount aforesaid shall be issued out of the Consolidated Revenue Fund after the end of the year mentioned in subsection (1) above.

(4) The function of issuing warrants for the purposes of this section shall be deemed to have been delegated by the Supreme Military Council to the Permanent Secretary of the Federal Ministry of Finance.

2. This Decree may be cited as the Appropriation Decree 1967 and shall apply throughout the Federation.
