THE STATES (CREATION AND TRANSITIONAL PROVISIONS) DECREE 1967

(1967 No. 14)

States (Appointment of Military Governors) (Amendment) Order 1967

Commencement : 27th May 1967

In exercise of the powers conferred upon me by section 1 (3) of the States (Creation and Transitional Provisions) Decree 1967 and of all other powers enabling me in that behalf, I, Lieutenant-Colonel Yakubu Gowon, Head of the Federal Military Government and Commander-in-Chief of the Armed Forces hereby make the following order :—

1. Immediately after section 1 (3) of the States (Appointment of Military Governors) Order 1967 there shall be inserted a new paragraph as follows—

“(4) The appointments of the undermentioned officers as set out in Government Notice No. 151 published in Gazette No. 6 of 26th January, 1966, Government Notice No. 1381 published in Gazette No. 75 of 28th July, 1966 and Government Notice No. 210 published in Gazette No. 7 of 9th February, 1967 are hereby revoked, that is to say the appointments of—

- (a) Lt.-Col. H. U. Katsina, as Military Governor of Northern Nigeria ;
- (b) Lt.-Col. C. O. Ojukwu, as Military Governor of Eastern Nigeria ;
- (c) Col. R. A. Adebayo, as Military Governor of Western Nigeria ;
- (d) Lt.-Col. D. A. Ejoor, as Military Governor of Mid-Western Nigeria ;
- (e) Major M. O. Johnson, as Military Administrator of the Capital Territory.”

2.—(1) This order may be cited as the States (Appointment of Military Governors) (Amendment) Order 1967 and shall apply throughout the Federation.

(2) This order shall be deemed to have come into operation on the 27th day of May 1967.

**NEWSPAPERS (PROHIBITION OF CIRCULATION) DECREE 1967
(1967 No. 17)**

The Biafra Sun (Prohibition of Circulation) Order 1967

Commencement : 30th May 1967

In exercise of the powers conferred by section 1 (1) of the Newspapers (Prohibition of Circulation) Decree 1967 the Head of the Federal Military Government hereby makes the following order :—

Circulation
of Biafra Sun
newspapers
prohibited.

Citation and
extent.

1. The circulation of any edition of the newspaper published in Nigeria under the name of the Biafra Sun and formerly known as the Nigerian Outlook is hereby prohibited.
2. This order may be cited as the Biafra Sun (Prohibition of Circulation) Order 1967 and shall have effect throughout the Federation.
