1. This Order may be cited as the Factories Act (Exemption) Order, 1967
2. The Naval Dockyards at Apapa and Calabar are hereby exempted from the provisions of the Factories Act.

MINERALS ACT (CHAPTER 121)

Prospecting (Areas and Minerals) Prohibition (Amendment)
Declaration 1967

Commencement : 22nd August 1967

In exercise of the powers conferred by section 8 of the Minerals Act, and of all other powers enabling me in that behalf, I hereby make the following declaration—

Citation and
application.

1. This Declaration may be cited as the Prospecting (Areas and Minerals) Prohibition (Amendment) Declaration 1967 and shall apply throughout the Federation.

2. Immediately after paragraph 54 of the Prospecting (Areas and Minerals) Prohibition Declaration there shall be inserted the following new paragraph:

"55. The following area is hereby declared to be closed to all prospecting for minerals :—

"All that parcel of land known as MRA.59 (formerly MLL.11915, 14954 and a portion of ML.11584) in the Jos Division of Plateau Province, containing an area of approximately 112.8 acres ; the boundaries of which are described below, that is to say :—

"Starting at a concrete beacon marked LM, MRA.59, the Colony Co-ordinates of which are :—

N.2,124,481 feet : E.2,326,773 feet : the boundaries run in straight lines, the bearings and lengths of which are as follows :—
