MINISTERS' STATUTORY POWERS AND DUTIES (MISCELLANEOUS PROVISIONS) ACT (CAP. 115)

TRADE DISPUTES (EMERGENCY PROVISIONS) DECREE 1968 (1968 No. 21)

Trade Disputes (Delegation of Statutory Functions) Order 1968

Commencement: 18th May 1968

In exercise of the powers conferred on me by section 3 of the Ministers' Statutory Powers and Duties (Miscellaneous Provisions) Act as modified by the Constitution (Miscellaneous Provisions) (No. 2) Decree 1967, and of all other powers enabling me in that behalf, I hereby make the following Order:—

- 1.—(1) The functions conferred on the Federal Commissioner for Labour under the provisions of the Trade Disputes (Emergency Provisions) Decree 1968 mentioned in column 1 of the Schedule hereto (which functions are, for convenience of reference only and without prejudice to this paragraph, described in column 2 of that Schedule) are hereby delegated to the person from time to time holding office as Permanent Secretary to the Federal Ministry of Labour.
- (2) Any person to whom any function is delegated by this Order shall, in deciding whether or how to exercise that function, have regard to any directions on matters of policy which may from time to time be given to him by the Federal Commissioner for Labour.
- (3) Nothing in this Order shall prevent the said Commissioner from exercising any of the functions delegated hereby.
- 2. This Order may be cited as the Trade Disputes (Delegation of Statutory Functions) Order 1968 and shall apply throughout the Federation.

- To receive report of declaration of a trade dispute.

Where a trade dispute is declared in the circumstances prescribed under section 4 of the Decree, to take such steps as he deems necessary to effect a settlement, other than steps specified in section 5 (3) (b) and (c) thereof.

Where a trade dispute is apprehended to inform the parties or their representatives of his apprehension of the dispute and of the steps he proposes to take for the purposes of resolving the dispute, other than steps specified in section 5 (3) (b) and (c) of the Decree.

## UNIVERSITY OF IBADAN ACT 1962 (1962 No. 37)

# University of Ibadan Statute No. 1 of 1968

Commencement: 1st October 1967

In exercise of the powers conferred by section 4(3) of the University of Ibadan Act 1962 the council of the University hereby makes the following statute :-

- 1.—(1) This statute may be cited as the University of Ibadan Statute No. 1 of 1968, and shall be deemed to have come into force on 1st October 1967.
- interpreta-(2) In this statute expressions used have the same meanings as in the University of Ibadan Act 1962 (hereafter in this statute referred to as "the 1962 No. 37. Act").

Apportionment of responsibility for university affairs.

Variation in quorum of

council and convocation.

- 2. In the First Schedule to the Act (which relates to principal officers of the university)-
  - (a) for paragraph 6 (1) there shall be substituted the following— "(1) There shall be a registrar who shall be responsible to the vice-

chancellor for the day to day administration of the affairs (other than financial affairs) of the university.";

(b) for paragraph 6 (5) there shall be substituted the following— "(5) Any question as to what are financial affairs of the university shall be determined by the vice-chancellor."

- 3. In the Second Schedule to the Act (which relates to constituent bodies of the university)-
  - (a) for paragraph 1 (6) there shall be substituted the following—
  - "(6) The quorum of the council shall be six."; (b) for paragraph 10 (1) there shall be substituted the following— "(1) The quorum of convocation shall be one hundred."
