Date of commencement.

THE MILITARY GOVERNOR OF THE RIVERS STATE OF NIGERIA hereby makes the following Edict:—

 This Edict may be cited as the Appropriation (1968-69) Edict, 1968, and shall be deemed to have come into operation on the 1st day of April, 1968. Title and commencement.

2. The Accountant-General of the Rivers State of Nigeria may, on the warrant of the Military Governor, issue from the Consolidated Revenue Fund during the year ending on the 31st day of March, 1969, any sums not exceeding in the whole the sum of six million five hundred fifty four thousand six hundred and ninety pounds being the total of the amounts set forth opposite the Heads specified in the Schedule.

Expenditure of £6,554,690 authorised out of Consolidated Revenue Fund.

3. The said sum shall be appropriated to the purpose and in the manner expressed in the Schedule.
