NIGERIAN RAILWAY CORPORATION ACT (CAP. 139)

Railway (Amendment) By-laws 1968

Commencement : 1st October 1968

In exercise of the powers conferred on it by section 58 of the Nigerian Railway Corporation Act, the Nigerian Railway Corporation hereby makes the following by-laws :---

1.—(1) These by-laws may be cited as the Railway (Amendment) By-laws 1968 and shall apply throughout the Federation.

(2) These by-laws shall come into force on 1st October 1968.

2. The Railway By-laws are hereby amended by inserting after by-laws 92 the following new by-law—

"Nuisance by obstruction etc. of railway. 93. A person shall not obstruct the railway in any manner so as to cause damage thereto or constitute a nuisance in the use of rolling stock thereon, or otherwise interrupt or endanger the smooth running of the railway.

"Penalty : Twenty Pounds"

THE AMPHETAMINE AND OTHER DRUGS (CONTROL) DECREE 1968

(1968 No. 5)

The Lysergic Acid Diethylamide (Control) Order 1968

Commencement : 5th September 1968

WHEREAS the Head of the Federal Military Government is satisfied that it is in the public interest to control the importation, or as the case may be the sale, of the substance known as Lysergic Acid Diethylamide under the Amphetamine and Other Drugs (Control) Decree 1968 (in this Order hereafter called "the Decree"):

Now THEREFORE in exercise of the powers conferred upon him by section 3 (1) of the Decree, Major-General Yakubu Gowon, Head of the Federal Military Government and Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria hereby makes the following order :---

1. Lysergic Acid Diethylamide (otherwise known as "L.S.D.") being deleterious to health shall be a controlled substance and accordingly the Schedule to the Decree aforesaid is amended by including after item 3 the following new item—

"4. Lysergic Acid Diethylamide (otherwise known as L.S.D.)."

2. This Order may be cited as the Lysergic Acid Diethylamide (Control) Order 1968 and shall be read with and form part of the Amphetamine and Other Drugs (Control) Decree 1968.
