Akira Ide Prohibited Immigrant Order 1969

Commencement : 19th March 1969

I, the Commissioner for Internal Affairs, being of opinion that the admission of AKIRA IDE into Nigeria would be contrary to the interest of national security and acting under the power conferred upon me by section 17 (1) (d) of the Immigration Act 1963 the said AKIRA IDE shall be deemed to be a prohibited immigrant and shall be refused admission into Nigeria and I hereby so order accordingly.

This Order may be cited as the AKIRA IDE Prohibited Immigrant Order 1969.

This Order may be cited as the PAKESHI OSUGA Prohibited Immigrant Order 1969.

**Mother Winifred Agnes Wilson (alias Mary Assumta)
Deportation Order 1969**

Commencement : 19th March 1969

I, the Commissioner for Internal Affairs, being of opinion that with effect from 19th March 1969, MOTHER WINIFRED AGNES WILSON (*alias* MARY ASSUMTA) ought to be classed as a prohibited immigrant and acting under the power conferred upon me by section 18 (3) of the Immigration Act 1963 hereby order the said MOTHER WINIFRED AGNES WILSON (*alias* MARY ASSUMTA) to be deported from Nigeria as a prohibited immigrant by the first available means and I direct that she shall thereafter remain out of Nigeria.

This Order may be cited as the MOTHER WINIFRED AGNES WILSON (*alias* MARY ASSUMTA) Deportation Order 1969, and shall be deemed to have come into force on 19th March 1969.

George Cary Bibler Deportation Order 1969

Commencement : 18th March 1969

I, the Commissioner for Internal Affairs, being of opinion that with effect from 18th March 1969, GEORGE CARY BIBLER ought to be classed as a prohibited immigrant and acting under the power conferred upon me by section 18 (3) of the Immigration Act 1963 hereby order the said GEORGE CARY BIBLER to be deported from Nigeria as a prohibited immigrant by the first available means and I direct that he shall thereafter remain out of Nigeria.

This Order may be cited as the GEORGE CARY BIBLER Deportation Order 1969.
