**Standing Orders of the Legal Practitioners Investigating
Panel (Amendment) Order 1970**

1. For Order 11 of the Standing Orders of the Legal Practitioners Investigating Panel 1964 there is hereby substituted the following new order—

“Procedure where panel finds a prima facie case made out against a legal practitioner. 11.—(1) If after the hearing, the panel finds that a person has misbehaved in a manner calculated or likely to bring opprobrium upon the legal profession (whether or not the misbehaviour amounts to infamous conduct in a professional capacity) and the panel is satisfied that disciplinary action is necessary, the panel may—

(a) refer the case to be dealt with by the tribunal as the tribunal may think fit; or

(b) if the misbehaviour does not amount to infamous conduct as aforesaid, give such direction as it thinks fit not inconsistent with the provisions of the Act.

(2) In any case within paragraph 11 (1) (a) of this order, the chairman shall prepare a report for the tribunal; and when it is signed by him it shall be the duty of the secretary to refer all relevant papers with the report to the tribunal.”

2. This Order may be cited as the Standing Orders of the Legal Practitioners Investigating Panel (Amendment) Order 1970.

CONSTITUTION OF THE FEDERATION (1963 No. 20)

The Public Service Commission (Delegation of Powers) Notice 1970

Commencement : 8th January 1970

In exercise of the powers conferred by section 147 (1) of the Constitution of the Federation and of all other powers enabling it in that behalf, the Public Service Commission of the Federation with the approval of the Head of the Federal Military Government hereby makes the following delegation :

1.—(1) Subject to the provisions hereunder, the powers specified in the Schedule hereto are hereby delegated to Permanent Secretaries and Heads of Extra-Ministerial Departments in the Public Service of the Federation in respect of posts in the Federal Public Service, whether established or unestablished, the initial basic salary of which is less than £621 per annum.

(2) The prior approval of the Public Service Commission (hereinafter referred to as "the Commission") shall be obtained before any of the powers hereby delegated is exercised in respect of—

(a) posts within the training grades in salary scale C ; and

(b) posts the initial basic salary of which is £364 per annum or more (but less than £621).

(3) The prior approval of the Commission shall likewise be obtained before disciplinary action (except reprimands) is taken against any officer of the permanent and pensionable establishment whose appointment has been confirmed.

2. Nothing in this notice shall prevent the exercise by the Commission of any power hereby delegated.

3.—(1) This Notice may be cited as the Public Service Commission (Delegation of Powers) Notice 1970.

(2) The Public Service Commission (Delegation of Powers) Notice published as Government Notice No. 95 of 1967 is hereby cancelled.

SCHEDULE

1. The power to appoint including appointment on promotion, transfer or secondment.

2. The power to confirm or terminate a probationary appointment.

3. The power to dismiss and exercise all other disciplinary control except surcharge.

Paul Elias Noujaim Deportation Order 1969

Commencement : 30th December 1969

I, the Federal Commissioner for Internal Affairs, being of opinion that PAUL ELIAS NOUJAIM at present in Nigeria ought to be classed as a prohibited immigrant and acting under the power conferred upon me by section 18 (2) of the Immigration Act 1963 hereby order the said PAUL ELIAS NOUJAIM to be deported from Nigeria as a prohibited immigrant by the first available means and I direct that the said PAUL ELIAS NOUJAIM shall thereafter remain out of Nigeria.

This Order may be cited as the PAUL ELIAS NOUJAIM Deportation Order 1969.

**John Antoine Younis (Prohibited Immigrant)
(Revocation) Order 1970**

WHEREAS in exercise of the powers conferred by section 18 (3) of the Immigration Act 1963 JOHN ANTOINE YOUNIS was on the 14th of March 1969 declared a prohibited immigrant and deported from Nigeria :

AND WHEREAS I am of the opinion that the Prohibited Immigrant Order be revoked :

NOW THEREFORE, in exercise of the power conferred by section 12 (1) (b) of the Interpretation Act 1964 and of all other powers enabling me in that behalf I, the Federal Commissioner for Internal Affairs, hereby revoke the said Prohibited Immigrant Order 1969.

This Order may be cited as the JOHN ANTOINE YOUNIS (Prohibited Immigrant) (Revocation) Order 1970.
