Interim Common Services Agency Decree 1968

(Extension of Operation) Order 1970

Commencement : 23rd February 1970

In exercise of the powers conferred on me by section 9 (1) of the Interim Common Services Agency Decree 1968 and of all other powers enabling me in that behalf, I, Major-General Yakubu Gowon, Head of the Federal Military Government and Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria hereby make the following Order—

1. The operation of the Interim Common Services Agency Decree 1968 is hereby extended for a period of one year, from 1st April 1970 to 31st March 1971.

CUSTOMS AND EXCISE MANAGEMENT ACT 1958
(1958 No. 55)

Open General Import Licence (All Countries) No. 2 of 1969
(Amendment) Notice 1970

Commencement : 20th February 1970

In exercise of the powers conferred upon him by section 4 (2) of the Imports Prohibition Order 1959, the Import Licensing Authority hereby gives Notice as follows :—

1. The Open General Import Licence (All Countries) No. 2 of 1969 is amended in Part A of Schedule 2 by the addition of the following items—

The effect of this Notice is that specific Import Licence is now required for the importation of fish, paints, varnishes and mosquito coil into Nigeria from all countries.

IMMIGRATION ACT 1963

(1963 No. 6)

Ael Israel Deportation Order 1970

Commencement : 12th March 1970

WHEREAS a recommendation by a court for the Deportation of AEL ISRAEL is in force :

AND WHEREAS I, Kam Selem, Commissioner for Internal Affairs after considering the recommendation aforesaid have thought it fit to make an order for deportation :

NOW THEREFORE, in exercise of the powers conferred upon me by section 20 (1) of the Immigration Act 1963 I hereby order that the said AEL ISRAEL shall, upon the expiration of any sentence of imprisonment passed on him, and at the first available opportunity leave Nigeria and thereafter remain out of Nigeria.

This order may be cited as the AEL ISRAEL Deportation Order 1970 and shall come into force on the day on which it is made.

IMMIGRATION ACT 1963
(1963 No. 6)

John Charles McInnes Deportation Order 1970

Commencement : 12th March 1970

I, Kam Selem, the Commissioner for Internal Affairs, being of opinion that with effect from 12th March 1970, JOHN CHARLES McINNES ought to be classed as a prohibited immigrant and acting under the powers conferred upon me by section 18 (3) of the Immigration Act, 1963 hereby order the said JOHN CHARLES McINNES to be deported from Nigeria as a prohibited immigrant by the first available means and I direct that he shall thereafter remain out of Nigeria.

This Order may be cited as the JOHN CHARLES McINNES Deportation Order 1970.
