Trade Disputes (Niger River Transport Limited Arbitration Award) Confirmation Order 1970

Commencement: 20th April 1970

In exercise of the powers conferred upon me by section 12 (2) of the Trade Disputes (Emergency Provisions) Decree 1968 as affected by section 7 (6) of the Trade Disputes (Emergency Provisions) (Amendment) (No. 2) Decree 1969 and of all other powers enabling me in that behalf, I hereby make the following Order:—

1. The arbitration tribunal award made on 10th April 1970 and set out in the Schedule hereto is hereby confirmed and shall have effect as therein provided.

Confirmation of award.

2. The award shall be deemed to have effect from 10th April 1970.

Effective date of award.

3. This Order may be cited as the Trade Disputes (Niger River Transport Limited Arbitration Award) Confirmation Order 1970 and shall apply throughout Nigeria.

Terms of Award

- 1. That there being no definite period of notice of retirement prescribed in the new Employees' Handbook, the notice of retirement given by the employers to the employees who were retired on 31st December 1968, was valid, it being the minimum period that could be given to determine the employment of a monthly paid worker.
- That the Management's exercise of its discretion in the matter was however unreasonable having regard to what the practice had been notwithstanding what the circumstances surrounding the decision to retire the men might have been.

Terms of Award

3. That this is a proper case for some monetary compensation employees concerned and I accordingly award to each employee retired on 31st December 1968 three (3) months' salary as compensation.
