

**THE SUPPLEMENTARY APPROPRIATION (1969-70) (No. 2)  
DECREE 1970**

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

**1.**—(1) The total of the amounts mentioned in section 1 of the Appropriation Decree 1969 and section 1 of the Supplementary Appropriation (1969-70) Decree 1970 (which enactments together provide for the issue out of the Consolidated Revenue Fund of the Federation in respect of the financial year ending on 31st March 1970, of sums not exceeding in aggregate £82,126,480) shall be increased by two million seven hundred and thirty-three thousand, one hundred and fifty pounds; and this additional amount shall be appropriated to the head of expenditure as indicated in the Schedule to this Decree and section 1 (3) of the Appropriation Decree 1969 (which provides for the lapse of balances outstanding at the end of the financial year) shall be construed subject to this Decree.

**BANKING (SPECIAL PROVISIONS) (AMENDMENT)  
(No. 2) DECREE 1970**

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1. The Banking (Special Provisions) Decree 1966 is hereby amended—

(a) in section 1 (1) (which relates to power to order investigation of bank accounts) by substituting for the words "direct the issue of orders" the words "direct the Governor of the Central Bank of Nigeria to instruct a bank examiner to issue orders", and by deleting the words "by him";

(b) in section 2 (2) (which relates to the period of a stop order on bank accounts) by adding at the end thereof the following proviso, that is—

"Provided that the period mentioned in any such order may, from time to time, by subsequent orders issued by a bank examiner be extended for a further period not exceeding one year at any one time."

2. This Decree may be cited as the Banking (Special Provisions) (Amendment) (No. 2) Decree 1970, and shall apply throughout the Federation.
