Immigration Act (Visa Abolition) Order 1971

Commencement : 1st June 1971

WHEREAS I, the Federal Commissioner for Internal Affairs, am satisfied that, pursuant to Visa Abolition Agreements concluded between Nigeria and the countries specified in the Schedule hereto, the Governments of those countries permit citizens of Nigeria to enter those countries without a visa or other entry permit :

NOW THEREFORE, in exercise of the powers conferred by section 31 (1) of the Immigration Act 1963 and of all other powers enabling me in that behalf, I, the Federal Commissioner for Internal Affairs, hereby make the following order :—

1. The requirement of a visa or other entry permit for the purposes of entry into Nigeria is hereby abolished in respect of the citizens of the countries specified in the Schedule hereto.

2.—(1) This Order may be cited as the Immigration Act (Visa Abolition) Order 1971 and shall apply throughout the Federation.

Confirmation of Award Notice 1971

Pursuant to the provision of section 4 (4) of the Trade Disputes (Emergency Provisions) (Amendment) (No. 2) Decree 1969, the Industrial Arbitration Tribunal Award made on 20th July 1970, as set out in the Schedule hereto, has been confirmed by me, the Federal Commissioner for Labour, and shall have effect as so confirmed in accordance with that provision.

That the Company do accept the men Mr Akinpelu and Mr Ogunseye back in their respective posts with effect from 19th December 1969, under the same terms and conditions of employment as they had enjoyed before the Company purported to dispense with their services ; 2. That a Christmas Bonus representing twenty-five per cent of their respective monthly salaries be paid to each of the said Mr Akinpelu and Mr Ogunseye as soon after their resumption of duty, as administrative action can be taken to effect the payment ; 3. That the said men be not subject to any disability whatsoever in respect of their employment by reason of their involvement in the dispute which culminated in the strike action taken by the Union at Kano on 15th December 1969.
