Instrument Extending Term of Office of the Vice-Chancellor of the University of Lagos

AND WHEREAS by paragraph 4 (3) of Schedule 1 to the University of Lagos Decree 1967 it is provided that the Vice-Chancellor of the University of Lagos shall hold office for such period and on such terms as may be specified in the instrument of appointment;

AND WHEREAS by an Instrument dated 28th November 1968 it is specified that DR SABURI OLADENI BIOBAKU'S appointment as Vice-Chancellor of the University of Lagos shall be for a period of five years with effect from 1st April, 1967 and it is expedient to extend the period of appointment by three months;

Now THEREFORE, I, GENERAL YAKUBU GOWON, Head of the Federal Military Government, Commander-in-Chief of the Armed Forces, hereby direct that the period specified in paragraph 4 of the said Instrument be extended for three months and paragraph 4 of the said Instrument is to that extent amended.
