Commencement.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows:—

1. The aggregate amount mentioned in section 1 of the Appropriation Decree 1971 shall be increased by four million, three hundred and forty-two thousand, one hundred and thirty pounds and this additional amount shall be appropriated to the head of expenditure specified in the Schedule to this Decree; and section 1 (3) of the Appropriation Decree 1971 (which provides for the lapse of balances outstanding at the end of the financial year) shall have effect accordingly.

Issue and appropriation of £4,342,130 from the Consolidated Revenue Fund for service of 1971-72.

2. This Decree may be cited as the Supplementary Appropriation (1971-72) Decree 1972.

- (c) by the insertion after section 3 of the following new section—

 "Special exemption with respect to purchase or charter of aircraft required by the Nigeria Airways Limited (formerly known as the W.A.A.C. (Nigeria) Limited) in connection with any services provided by that company."

The above Decree amends the Corporations Standing Tenders Board Decree 1968 to make it clear that the powers of the Corporation Standing Tenders Board does not include the power to supervise the award of contracts relating to the purchase or charter of aircraft required by the Nigeria Airways.
