

# UNIVERSITY COLLEGE HOSPITAL (AMENDMENT) DECREE 1972



## Decree No. 33

[29th August 1972]

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :

1. For section 5 of the University College Hospital Act as amended by the University College Hospital (Amendment) Act 1965 (which deals with the composition of the University College Hospital Board of Management) there shall be substituted the following—

'5.—(1) The Board shall consist of a Chairman and nine other members.

(2) The Chairman shall be the Permanent Secretary, Federal Ministry of Health ; and the other members shall be—

(a) the Permanent Secretary, Federal Ministry of Finance or his representative ;

(b) the Chief Medical Adviser to the Federal Military Government, or his representative ;

(c) three members being persons who have a wide variety of community interests in health matters who shall be appointed by the Commissioner after consultation with the Head of the Federal Military Government ;

(d) one member who shall be appointed by the Nigeria Medical Association ;

(e) the Director-General, Armed Forces Medical Services or his representative ;

(f) the Dean of the Medical School, University of Ibadan ;

(g) the Vice-Chancellor, University of Ibadan or his representative ;

(h) one person nominated by the Senate, University of Ibadan and appointed by the Commissioner ; and

(i) the chairman of the Medical Advisory Committee or his representative.

(3) For the purposes of this Act, the members referred to in paragraphs (a), (b), (e), (f), (g) and (i) above shall be known as "ex-officio members."

(4) The reference in this section to a representative of a member of the Board is a reference to a person duly appointed by the member to represent him.'

Amendment  
of section 10.

2. In section 10 (3) of the said University College Hospital Act (which provides for the quorum for meetings of the Board) for the word "seven" there shall be substituted the word "five".

Citation.

3. This Decree may be cited as the University College Hospital (Amendment) Decree 1972.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :

1. The Schedule to the Lagos University Teaching Hospital Act 1961 (which relates to the composition of the membership of the Board of Management of the Hospital established under section 3 of the said Act) is hereby amended as follows, that is to say—

(a) for paragraph 1 thereof, there shall be substituted the following—

'1.—(1) The Board shall consist of the following members—

(a) the Permanent Secretary, Federal Ministry of Health, who shall be the Chairman ;

(b) the Permanent Secretary, Federal Ministry of Finance or his representative ;

(c) the Chief Medical Adviser to the Federal Military Government or his representative ;

(d) three members being persons who have a wide variety of community interests in health matters who shall be appointed by the Commissioner after consultation with the Head of the Federal Military Government ;

(e) one person appointed by the Nigeria Medical Association ;

(f) the Director-General, Armed Forces Medical Services or his representative ;

(g) the Provost, College of Medicine, University of Lagos ;

(h) the Vice-Chancellor, University of Lagos or his representative ;

(i) one person nominated by the Senate, University of Lagos and appointed by the Commissioner ; and

(j) the chairman of the Medical Advisory Committee or his representative.

(2) The reference in this paragraph to a representative of a member of the board is a reference to a person duly appointed by the member to represent him.

(3) A member holding office by virtue of sub-paragraph (d), (e) or (i) above is hereafter in this Schedule referred to as a "nominated member".

(b) for sub-paragraph (1) of paragraph 2 there shall be substituted the following new sub-paragraph :—

"(1) A nominated member shall hold office for such period not exceeding four years as may be specified in his instrument of appointment." ;

(c) in paragraph 3 (1) (c) for the words "clause (g)" there shall be substituted the words "paragraph 1 (1) (d)" ;

(d) in paragraph 5 for the word "seven" there shall be substituted the word "five".

2. This Decree may be cited as the Lagos University Teaching Hospital (Amendment) Decree 1972.
