1. The Statutory Corporations Service Commission Decree 1968 shall cease to apply to Nigeria Airways Limited and, accordingly, paragraph (b) of section 14 (4) of the said Decree is hereby repealed.

2. This Decree may be cited as the Statutory Corporations Service Commission (Amendment) (No. 2) Decree 1972 and shall be deemed to have come into force on 21st October 1972.
