## COPYRIGHT DECREE 1970 (1970 No. 61)

## Customs and Excise (Copyright) Regulations 1973

Commencement: 24th April 1973

In exercise of the powers conferred by section 15 (5) of the Copyright Decree 1970, and of all other powers enabling me in that behalf, I hereby make the following Regulations:—

1. The notice in writing to be given to the Board of Customs and Excise under section 15 of the Copyright Decree 1970 shall be in the Form A or Form B as set out in the Schedule hereto. A separate notice on Form A or Form B shall be given in respect of each work. A separate notice on Form C or Form D shall be given in respect of each importation, whether of one or more works.

Form of Notice.

2. A fee of \$\frac{100}{100}\$ in respect of each notice shall be paid to the Board of Customs and Excise at the time such notice is given.

Fee.

3. The owner of the copyright in any published literary, dramatic or musical work for which a notice has been given shall notify the Board in writing of any change of ownership or other change affecting the notice within twenty-eight days of such change. On a change of ownership of copyright, whether notified to the Board or not, any notice given to the Board under the provisions of regulation 1 above shall be deemed to have been withdrawn as from the expiry of a period of twenty-eight days from the change of ownership.

Change of ownership.

4. The owner of the copywright in any work, and any agent of his, who gives a notice shall either at the time of giving the notice or at the time when the work is imported, or at both such times, furnish to the Board such evidence and information within such time as it may require, and shall produce within such time as it may specify such books or other documents as it may require. If such evidence and information are not furnished within twenty-one days from the time such are required by the Board, the notice filed by the owner of the Copyright or his agent shall be deemed to have been withdrawn.

Owner to furnish evidence.

5. The owner of the copywright in any work, or any agent of his, who gives notice, shall give to the Board security of \$\frac{N}{2},000\$ on Form E within such time and in such manner, whether by bond, deposit of a sum of \$\frac{N}{2},000\$ or any greater sum of money as the Board may require, against all actions, proceedings, claims, and demands whatsoever which may be taken or made against, or costs and expenses which may be incurred by it in consequence of the detention of any copy to which the notice relates. Such security or further security shall be given at the time the notice is given or at such other time as the Board may require. If such security or further security is not given within the time or in the manner required by the Board, the notice shall be deemed to have been withdrawn as from the expiry of the time so required.

Bond and security.

Indemnification of Board.

- 6. In every case-
- (a) in which the Board has not required the security or further security referred to in Regulation 5 to be given, or
- (b) in which the Board has taken security and that security is insufficient, or
- (c) in which the notice is deemed to have been withdrawn under Regulation 3, 4 or 5,

the owner of the copyright in any work, and any agent of his, who has given a notice shall jointly and severally keep the Board indemnified against all actions, proceedings, claims and demands whatsoever which may be taken or made against it, and shall repay to the Board all costs expenses which may be incurred by it in consequence of the detention of, or anything done in relation to, any copy of a work to which the notice relates. Any such costs, expenses, damages or other sums may be recovered as a debt due to Federal Military Government of Nigeria.

Revocation, transitional and saving provisions. 7.—(1) The Regulations contained in Chapter 40 of the Laws of the Federation of Nigeria and Lagos 1958 (in so far as they have effect in Nigeria) are hereby revoked.

(2) The provision of paragraph 1 above notwithstanding, any notices given after the commencement of Copyright Decree 1970 under the Regulations hereby revoked shall continue in force either by those Regulations or under the appropriate provisions of these Regulations.

Citation.

8. These Regulations may be cited as the Customs and Excise (Copyright) Regulations 1973.

Bond and Security given by Owner of Copyright to Board of Customs and Excise

Whereas the work or works specified in the schedule hereto are the subject of a notice given by the owner or agent of the owner of the copyright therein to the Board of Customs and Excise (hereinafter called the Board).

AND WHEREAS it is necessary for the Board to detain such goods in its custody for a period specified in the Notice.

AND WHEREAS without prejudice to its right to require further and better security, the surety at the request of the owner and with the approval of Board has agreed to become surety for the owner:

Now the Condition of the bond theretofore affixed is such that the owner of the copyright in the work or works as above-mentioned shall give to the Board security of N2,000 within such time as in such manner, whether as agreed to by the bond, or by a deposit of the sum of N2,000; the bond or deposit to stand as indemnity to the Board as against all actions, proceedings, claims, and demands whatsoever which may be taken or made against, or costs and expenses which may be incurred by the Board in consequence of the detention of any copy to which the owner gives Notice to the Board. And such other time as the Board may require.

Now wherefore we (owner of Copyright) of (Address) and (Surety) of (address, etc.) are held and firmly bound unto the Board of Customs and Excise in the sum of two thousand Naira (N2,000) to be paid to the Board well and truly to be made we bind ourselves and each of us jointly and severally firmly by these presents.

In exercise of the powers conferred by section 44 of the Insurance Companies Act 1961, and of all other powers enabling me in that behalf, I, the Federal Commissioner for Trade, hereby make the following regulations:—

- 1. The Insurance Companies Regulations 1968 shall be amended as follows:—
  - (a) in regulation 2 (1) immediately before the definition of "motor vehicle insurance business" there shall be inserted the following new definition—

"miscellaneous insurance business" means the issue of, or the undertaking of liability under policies, which do not fall within any of the classes of insurance mentioned in paragraphs (a) to (f) of Regulation 3 of these regulations.

- (b) in regulation 3 after paragraph (f) thereof there shall be added the following new sub-paragraph—
  - "(g) miscellaneous insurance business"
- These regulations may be cited as the Insurance Companies Citation. (Amendment) Regulations 1973.

KNOW YE, THEREFORE, that I, do by this Instrument give and grant unto the person(s) above named and any successor(s), executor(s), administrator(s) and assign(s) (each and any of whom are hereinafter referred to as the patentee) my especial licence, full power, sole privilege and authority, that the patentee or any agent or licensee of the patentee may subject to the conditions and provisions prescribed by any statute or order for the time being in force at all times hereafter during the term of years herein mentioned, make, use, exercise and vend the said invention throughout the Federal Republic of Nigeria, and that the patentee shall have and enjoy the whole profit and advantage from time to time accruing by reason of the said invention during the term of twenty years from the date first above written on this Instrument: AND to the end that the patentee may have and enjoy the sole use and exercise of the full benefit of the said invention, I do by this Instrument strictly command all citizens of the Federal Republic of Nigeria that they do not at any time during the continuance of the said term either directly or indirectly make use of or put in practice the said invention, nor in anywise imitate the same, without the written consent, licence or agreement of the patentee, on pain of incurring such penalties as may be justly inflicted on such offenders, and of being answerable to the patentee according to law for damages thereby occasioned:

PROVIDED ALWAYS that this patent shall be revocable on any of the grounds from time to time by law prescribed as grounds for revoking patents granted by me, and the same may be revoked and made void accordingly:

PROVIDED ALSO that nothing herein contained shall prevent the granting of licences in such manner and for such considerations as they may by law be granted.
