Confirmation of Award Notice 1973**

Pursuant to the provisions of section 4 (4) of the Trade Disputes (Emergency Provisions) (Amendment) (No. 2) Decree 1969, the Industrial Arbitration Tribunal Award made on 16th June 1972 as set out in the Schedule hereto, has been confirmed by me, the Federal Commissioner for Labour, and shall have effect as so confirmed in accordance with that provision.

IMMIGRATION ACT 1963
(1963 No. 6)

Enzo Gentile Deportation Order 1973

Commencement : 8th May 1973

I, the Federal Commissioner for Internal Affairs, being of the opinion that ENZO GENTILE at present in Nigeria ought to be classified as a prohibited immigrant and acting under the power conferred upon me by section 18 (2) of the Immigration Act 1963 hereby order the said ENZO GENTILE to be deported from Nigeria by the first available means and direct that the said ENZO GENTILE shall thereafter remain out of Nigeria.

This Order may be cited as the ENZO GENTILE Deportation Order 1973 and shall come into operation on the 8th day of May 1973.
