**Civil Aviation (Fees) (Amendment) Regulations 1973**

*Commencement : 1st September 1973*

In exercise of the powers conferred upon me by Regulation 78 of the Civil Aviation (Air Navigation) Regulations 1965 and of all other powers enabling me in that behalf, I, Russell Aliyu Barau Dikko, Federal Commissioner for Transport, hereby make the following regulations :—

1. In regulation 5 of the Civil Aviation (Fees) Regulations 1965 for the words "seven shillings and six pence" there shall be substituted the words "one naira."
