TRIBUNALS OF INQUIRY DECREE 1966 (1966 No. 41)

Instrument Constituting a Tribunal of Inquiry into the Administration of the House Governor, University College Hospital, Ibadan

Under the powers conferred upon me by section 1 of the Tribunals of Inquiry Decree 1966 and all other powers enabling me in that behalf, I, GENERAL YAKUBU GOWON, Head of the Federal Military Government, Commander-in-Chief of the Armed Forces, hereby constitute and appoint a Tribunal of Inquiry with the term of reference herein-after appearing:

to be members of the Tribunal with full powers to hold public meetings:

AND I direct that Mr Justice Mu'azu Mohammed aforesaid shall be the Chairman and I appoint Mr E. J. UTUK to be Secretary to the Tribunal:

AND I further direct that any three members of the Tribunal of whom one shall be the Chairman shall constitute a quorum and the Tribunal shall hold its first meeting in Ibadan not later than three weeks from the date of this Instrument and shall thereafter hold the said inquiry at such places and upon such dates as the Chairman may direct; and, subject to the foregoing, the tribunal shall in accordance with section 4 of the Decree have power to regulate its proceedings.

Term of Reference

- 2. The Tribunal shall with all convenient speed inquire into the complaints against Mr S. A. Ladeinde in his capacity as the House Governor of the University College Hospital, Ibadan, and, arising from its findings, make such recommendations as it may deem necessary for the orderly administration of the hospital.
- 3. AND I hereby require the Tribunal to submit its report to me in Lagos not later than three months from the date of its first meeting.

IMMIGRATION ACT 1963 (1963 No. 6)

Ali Khalil Hijazi Deportation Order 1973

Commencement: 16th August 1973

I, the Federal Commissioner for Internal Affairs, being of the opinion that ALI KHALIL HIJAZI at present in Nigeria ought to be classified as a prohibited immigrant and acting under the power conferred upon me by section 18 (2) of the Immigration Act 1963 hereby order the said ALI KHALIL HIJAZI to be deported from Nigeria by the first available means and I direct that the said ALI KHALIL HIJAZI shall thereafter remain out of Nigeria.

This Order may be cited as ALI KHALIL HIJAZI Deportation Order 1973 and shall be deemed to have come into effect on 16th August 1973.
