## NATIONAL YOUTH SERVICE CORPS 1973

(1973 No. 24)

## National Youth Service Corps (Exemption, etc.) Order 1974

Commencement : 14th March 1974

In exercise of the powers conferred by section 15 (1) and (2) of the National Youth Service Corps Decree 1973 and of all other powers enabling it in that behalf, the Directorate of the National Youth Service Corps, with the approval of the Federal Executive Council, hereby makes the following Order :—

1. The persons listed in Schedule 1 below are hereby exempted from the National Youth Service Corps Scheme.

2.—(1) The participation in the National Youth Service Corps Scheme of the person mentioned in Schedule 2 is hereby deferred for a period of three months (August to October 1973) to enable her consult her doctor in the United Kingdom.

(2) The participation in the National Youth Service Corps Scheme of the graduates listed in :—

(a) Schedule 3 is hereby deferred for the period specified respectively against their names,

(b) Schedule 4, being pregnant women, is hereby deferred for the period specified respectively against their names.

3. This Order may be cited as the National Youth Service Corps (Exemption, etc.) Order 1974.

## Trade Unions Regulations 1974

Commencement : 28th February 1974

In exercise of the powers conferred by section 54 of the Trade Unions Decree 1973 and of all other powers enabling me in that behalf, I, Anthony Enahoro, Federal Commissioner for Labour, hereby make the following regulations :—

- Forms. 1. The forms set out in Schedule 1 to these regulations shall be used in all cases to which they are applicable, and may be modified as directed by the Registrar to meet other cases.
- Fees. 2. The fees set out in Schedule 2 to these regulations shall be payable in cases to which they relate.
- Citation. 3. These regulations may be cited as the Trade Unions Regulations 1974.
