# PENSIONS (INCREASE) DECREE 1975



## Decree No. 42

[1st April 1974]

Commencement.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows:—

1.—(1) Subject to the provisions of this Decree, there shall be payable as from the appointed day to every person who retired before the appointed day and who was in receipt of a pension under the provisions of any enactment mentioned in Part A of the Schedule to this Decree, an increase in pension as specified in the table set out in Part B of the said Schedule:

Increase in pensions and minimum pension payable.

Provided that where an increase would operate in such a way that the minimum annual pension payable together with any such increase would be less than N360, the minimum annual pension including such increase shall be N360.

- (2) Notwithstanding the provisions of any enactment aforesaid, the minimum annual pension to be paid to any person pursuant to any such enactment shall, as from the appointed day, be ₹360.
  - 2. In this Decree-

"the appointed day" means the date of commencement of this Decree;

"pensions" means the yearly amount of the pension granted to an officer or other person on the date of his retirement or the yearly amount of pension as reduced by commutation under the Pensions Regulations, as the case may be, inclusive in either case of increases payable before the appointed day and includes any annual allowance in the nature of a pension.

Interpreta-

3.—(1) This Decree may be cited as the Pensions (Increase) Decree 1975 and shall be deemed to have come into operation on 1st April 1974.

Citation, etc..

- (2) For the avoidance of doubt, the provisions of any enactment aforementioned in force immediately before the appointed day shall, as from the appointed day, be read and construed with such adaptations and modifications as may be necessary or expedient for bringing into force the provisions of this Decree; and in particular, the amount of any increase granted pursuant to the provisions of this Decree shall not be taken into account for the purposes of section 10 of the Pensions Act (which limits the amount of a pension that may be granted to an officer).
- (3) The Pensions (Increase) Act and the Pensions (Increase) Decree 1972 are hereby consequentially repealed.

(a) Not more than ₹720 per annum	50 per cent increase subject to a minimum of N360 per annum.	
(b) Over ₹720 but not more than ₹3,000 per annum	40 per cent increase or N400 per annum, whichever is higher.	
(c) Over ₹3,000 per annum	30 per cent increase or ₩1,300 per annum, whichever is higher.

#### EXPLANATORY NOTE

The Decree effects various rates of increments in pensions for government officers already in retirement before the effective date of implementation of the Udoji Public Service Review Commission recommendation relating to pensions.

The minimum pension now payable is ₹360 per annum.
