Companies (Special Provisions) (Exemptions) Order 1975

Commencement : 28th February 1975

In exercise of the powers conferred by section 1 (3) of the Companies (Special Provisions) Decree 1973 and of all powers enabling it in that behalf, the Federal Executive Council hereby makes the following Order :—

1. The foreign companies listed in the first column of the Schedule to this Order being companies engaged in the projects specified in the second column of the said Schedule are hereby exempted from the provisions of Part X of the Companies Decree 1968 for the periods respectively set against each company in the third column of that Schedule.

Exemption from the requirements of Part X of 1968 No. 5.

2. This Order may be cited as the Companies (Special Provisions) (Exemption) Order 1975.

**Trade Disputes (General Approval of Increases in
Salaries and Wages) Order 1975**

Commencement : 20th February 1975

In exercise of the powers conferred by section 7 (1) of the Constitution (Suspension and Modification) Decree 1966 and of all other powers enabling him in that behalf, the Head of the Federal Military Government, Commander-in-Chief of the Armed Forces, hereby makes the following Order :—

1. The approval of the Federal Military Government required by section 5 (1) of the Trade Disputes (Emergency Provisions) (Amendment) (No. 2) Decree 1969 is hereby given to all grants of increases in salaries or wages made or offered to employees not in the public services of Nigeria by their employers provided that such increases are granted pursuant to agreements concluded with the employees concerned following negotiations held as directed by the Government in paragraph 131 of the "Government Views on the Report of the Public Service Review Commission" published in December 1974.

2. This Order may be cited as the Trade Disputes (General Approval of Increases in Salaries and Wages) Order 1975.
