# WEIGHTS AND MEASURES DECREE 1974 (1974 No. 34)

## Weights and Measures (Revocation) Order 1975

Commencement: 21st August 1975

In exercise of the powers conferred upon me by section 52 (2) of the Weights and Measures Decree 1974 and of all other powers enabling me in that behalf, I, Brigadier Mohammed Shuwa, Federal Commissioner for Trade, hereby make the following Order:
