EXPORT OF NIGERIAN PRODUCE ACT 1958

**Export of Nigerian Produce
(Prescribed Standard and Grades for Copra)
Regulations 1975**

Commencement : 1st July 1975

In exercise of the powers conferred by sections 3 (a) and 8 (d) of the Export of Nigerian Produce Act 1958, and of all other powers enabling me in that behalf, I, Brigadier Mohammed Shuwa, the Federal Commissioner for Trade, hereby make the following Regulations :—

1. The standard and grades for copra purchased by the States Marketing Boards for export shall be as set out in paragraphs (a) and (b) of this regulation respectively :—

Prescribed standard and grades for copra.

(a) The standard shall be of "exportable quality" which means copra which is thoroughly dry and contains not more than 20 per cent by weight of total defects and extraneous substances which shall include not more than 6 per cent by weight of mouldy and immature pieces of copra ;

(b) There shall be three grades of copra :—

(i) *Grade I* : copra which is thoroughly dry and contains not more than 5 per cent by weight of total defects and extraneous matter which shall be inclusive of not more than 3 per cent by weight of mouldy and immature pieces.

(ii) *Grade II* : copra which does not qualify for Grade I but which is thoroughly dry and contains not more than 10 per cent by weight of total defects and extraneous matter which shall be inclusive of not more than 6 per cent by weight of mouldy and immature pieces.

(iii) *Grade III* : copra which does not qualify for either Grade I or Grade II but which is thoroughly dry and contains more than 10 per cent by weight but not more than 20 per cent by weight of total defects and extraneous matter which shall be inclusive of not more than 6 per cent by weight of mouldy and immature pieces.

2. These Regulations may be cited as Export of Nigerian Produce (Prescribed Standard and Grades for Copra) Regulations 1975.
