TRADE UNIONS DECREE 1973
(1973 No. 31)

Trade Union (Compulsory Recognition) Order 1976

Commencement : 27th March 1976

In exercise of the powers conferred by section 22 (2) of the Trade Unions Decree 1973, and of all other powers enabling me in that behalf, I, Major-General Henry Edmund Olufemi Adefope, the Federal Commissioner for Labour, hereby make the following Order :—

1.—(1) The Consolidated Petroleum, Chemical and General Workers' Union of Nigeria is entitled to be recognised by Michelin (Nigeria) Limited as representing the junior workers in the employment of that company.

Compulsory recognition order in respect of Michelin (Nig.) Ltd. and a trade union.

(2) Accordingly, with effect from the publication of this Order in the *Gazette*, the said union shall be recognised by Michelin (Nigeria) Limited as representing the junior workers of the company and shall be so dealt with by the company for the following purposes, that is to say—

(a) collective bargaining in respect of—

(i) wages and salaries of the junior workers,

(ii) hours of work and general conditions of service of the said workers ; and

(b) such other ancillary matters as are normally within the competence of a trade union.

2. This Order may be cited as the Trade Union (Compulsory Recognition) Order 1976.

EXPLANATORY NOTE

(This note does not form part of the above Order but is intended to explain its effect)

The Order provides for the compulsory recognition of the Consolidated Petroleum, Chemical and General Workers' Union of Nigeria by Michelin (Nigeria) Limited in view of the latter's refusal to do so voluntarily.

Chinde Piere Deportation Order 1976

Commencement : 30th March 1976

WHEREAS a recommendation by a court of competent jurisdiction for the deportation of Chinde Piere is in force :

AND WHEREAS the Federal Commissioner for Internal Affairs has, after considering the recommendation aforesaid, thought it fit to make an order for the deportation of the said Chinde Piere :

NOW, THEREFORE, in exercise of the powers conferred upon me by section 20 (1) of the Immigration Act 1963, I, the Federal Commissioner for Internal Affairs, hereby order the said Chinde Piere to be deported from Nigeria by the first available means and direct that the said Chinde Piere shall thereafter remain out of Nigeria.

This Order may be cited as the Chinde Piere Deportation Order 1976.
