I, the Federal Commissioner for Internal Affairs, being of opinion that Peter Maguire Thwaite at present in Nigeria ought to be classified as a prohibited immigrant and acting under the powers conferred by section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said Peter Maguire Thwaite be so classified and further order that the said Peter Maguire Thwaite be deported from Nigeria by the first available means and I direct that the said Peter Maguire Thwaite shall thereafter remain out of Nigeria.

This Order may be cited as the Peter Maguire Thwaite Deportation Order 1976.

Commencement : 1st April 1976

I, the Federal Commissioner for Internal Affairs, being of opinion that David Boorman at present in Nigeria ought to be classified as a prohibited immigrant and acting under the powers conferred by section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said David Boorman be so classified and further order that the said David Boorman be deported from Nigeria by the first available means and I direct that the said David Boorman shall thereafter remain out of Nigeria.

This Order may be cited as the David Boorman Deportation Order 1976 and shall be deemed to have come into force on the 1st day of April 1976.

TRADE DISPUTES DECREE 1976

(1976 No. 7)

Trade Disputes (Delegation of Certain Statutory Functions) Order 1976

Commencement : 20th April 1976

In exercise of the powers conferred upon me by section 3 of the Ministers' Statutory Powers and Duties (Miscellaneous Provisions) Act, as modified by the Constitution (Miscellaneous Provisions) (No. 2) Decree 1967, and of all other powers enabling me in that behalf, I, Major-General Henry Edmond Olufemi Adefope, the Federal Commissioner for Labour, hereby make the following Order :—

1.—(1) The functions conferred on the Federal Commissioner for Labour, under the provisions of the Trade Disputes Decree 1976, mentioned in column 1 of the schedule hereto, are hereby delegated to the Permanent Secretary, Federal Ministry of Labour.

(2) In exercising the functions delegated under this section, the Permanent Secretary shall have regard to any directions on matters of policy which may from time to time be given to him by the Commissioner.

(3) Nothing in this Order shall prevent the Commissioner from exercising any of the functions hereby delegated.

2. This Order may be cited as the Trade Disputes (Delegation of Certain Statutory Functions) Order 1976.

STATUTORY FUNCTIONS DELEGATED

<i>Section</i>	<i>Function delegated</i>
4	To receive report of declaration of a trade dispute.
5	Where a trade dispute is declared in the circumstances prescribed under section 4 of the Decree, to issue a notice in writing specifying the steps which must be taken, to satisfy the requirements of sections 3 and 4 of the Decree.
6	For the purposes of section 5 of the Decree, to appoint a fit person to act as conciliator.
