**Trade Dispute (Lipton Workers' Union of Nigeria and
Lipton of Nigeria Limited) Confirmation of Award Notice 1976**

Pursuant to the provision of section 9 (3) of the Trade Disputes Decree 1976, the Industrial Arbitration Tribunal Award made on 21st May 1976, and set out in the Schedule hereto, has been confirmed by me, the Federal Commissioner for Labour, and shall have effect as so confirmed in accordance with that provision.

- "(a) That the Tribunal makes no award in respect of claims Nos. 2, 3, 4 and 5 in the terms of reference of this dispute.
- (b) That Lipton of Nigeria Limited do pay - with effect from the date of declaring them redundant the following rates to every employee so declared, that it to say ;
- (i) One month's wage in lieu of notice.
 - (ii) Two weeks' pay for each year of service ; a period of six months over any completed year shall for the purpose of this award be regarded as one year.
 - (iii) An *ex gratia* payment of ₦150.00 (one hundred and fifty naira only) to be made to every employee who has been declared redundant".
