Now, THEREFORE, in exercise of the powers conferred upon me by section 20 (1) of the Immigration Act 1963, and of all other powers enabling me in that behalf, I, the Federal Commissioner for Internal Affairs, hereby order the said Jerome Neal to be deported from Nigeria by the first available means and direct that the said Jerome Neal shall thereafter remain out of Nigeria.

This order may be cited as the Jerome Neal Deportation Order 1977.

Wong Sun Chi Deportation Order 1977
