**PUBLIC LANDS ACQUISITION (MISCELLANEOUS PROVISIONS)  
DECREE 1976 (1976 No. 33)**

**Instrument Constituting Lands Tribunals in the States of  
the Federation**

In exercise of the powers conferred upon me by section 12 of the Public Lands Acquisition (Miscellaneous Provisions) Decree 1976 and of all other powers enabling me in that behalf, I, Lieutenant-General Olusegun Obasanjo, Head of the Federal Military Government, Commander-in-Chief of the Armed Forces, after consultation with the respective authorities specified in paragraphs (a) and (b) of section 12(3) of the Decree, hereby constitute and appoint a lands tribunal for each of the States specified in column 1 of the Schedule hereto.

AND I direct that the person specified in column 2 of the Schedule shall be the Chairman of the relevant State's Lands Tribunal while the persons specified in column 3 thereof shall be assessors to that Tribunal.

AND I further direct that a member of a State's Lands Tribunal shall hold office for a period of three years from the date of this Instrument.
