CONSTITUTION OF THE FEDERATION (1963 No. 20)

Nigerian Citizenship (Amendment) Regulations 1978

Commencement: 13th March 1978

In exercise of the powers conferred by section 16 of the Constitution of the Federation (as amended by the Constitution (Amendment) Decree 1974) and of all other powers enabling me in that behalf, I, Umaru Ali Shinkafi, Federal Commissioner for Internal Affairs, with the approval of the Federal Executive Council, hereby make the following Regulations:—

1. The Schedule to the Nigerian Citizenship Regulations 1974 is hereby amended by the insertion immediately after Form F of the new Form G specified in the Schedule hereto.
