**William D. Lancaster Deportation Order 1978***Commencement : 21st March 1978*

I, the Federal Commissioner for Internal Affairs being of the opinion that William D. Lancaster at present in Nigeria ought to be classified as a prohibited immigrant and acting under the powers conferred upon me by Section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said William D. Lancaster be deported from Nigeria by the first available means and I direct that the said William D. Lancaster shall thereafter remain out of Nigeria.

This Order may be cited as the William D. Lancaster Deportation Order 1978.

## IMMIGRATION ACT 1963

**Heinrich Mayer (Prohibited Immigrant) Order 1978***Commencement : 21st March 1978*

I, the Federal Commissioner for Internal Affairs being of the opinion that the admission of Heinrich Mayer into Nigeria would be contrary to the interest of national security and is therefore in accordance with the provisions of Section 17 (1) (d) of the Immigration Act 1963, deemed to be a prohibited Immigrant, and acting under the powers conferred upon me by Section 17 of the said Act, and of all other powers enabling me in that behalf, order that the said Heinrich Mayer be refused admission into Nigeria accordingly.

This Order may be cited as the Heinrich Mayer (Prohibited Immigrant) Order 1978.

Civil Aviation (Fees) (Amendment) Regulations 1978
