In exercise of the powers conferred by section 149 of the Electoral Decree 1977, and of all other powers enabling it in that behalf, the Federal Electoral Commission hereby makes the following regulations:—

1. For Form PP 1 in the Schedule to the Political Parties (Registration, etc.) Regulations 1978, there shall be substituted the new Form PP 1 contained in the Schedule to these regulations.

EXPLANATORY NOTE

(This note does not form part of the above Regulations but is intended to explain the effect thereof)

As a consequence of the requirement for effective establishment of branch offices together with proper organisation at the local level in at least two-thirds of the States by political associations now introduced by the Electoral (Amendment) Decree 1978, the regulations prescribe a new application form, reflecting the said requirement, for registration of political parties.
