

## APPROPRIATION DECREE 1979



## Decree No. 38

[1st April 1979]

Commence-  
ment.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1.—(1) The Accountant-General of the Federation may, when authorised to do so by warrants signed by the Federal Commissioner for Finance, pay out of the Consolidated Revenue Fund of the Federation during the year ending 31st March 1980 the sums specified by the warrants, not exceeding in the aggregate eight billion, eight hundred and five million, two hundred and sixty-two thousand, three hundred and ten naira.

(2) The amount mentioned in the foregoing subsection shall be appropriated to heads of expenditure as indicated in the Schedule to this Decree.

(3) No part of the amount aforesaid shall be issued out of the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.

2. This Decree may be cited as the Appropriation Decree 1979 and shall be deemed to have come into operation on 1st April 1979.
