**Nigel Collingwood Turner Deportation Order 1980**

*Commencement : 13th January 1980*

I, the Minister for Internal Affairs, being of opinion that Nigel Collingwood Turner at present in Nigeria ought to be classified as a prohibited immigrant and acting under the powers conferred by section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said Nigel Collingwood Turner be so classified and further order that the said Nigel Collingwood Turner be deported from Nigeria by the first available means and I direct that the said Nigel Collingwood Turner shall thereafter remain out of Nigeria.

This Order may be cited as the Nigel Collingwood Turner Deportation Order 1980.

**Umberto Carnazzi Deportation Order 1980**

*Commencement : 7th January 1980*

I, the Minister for Internal Affairs, being of opinion that Umberto Carnazzi at present in Nigeria ought to be classified as a prohibited immigrant, and acting under the powers conferred by section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said Umberto Carnazzi be so classified and further order that the said Umberto Carnazzi be deported from Nigeria by the first available means and I direct that the said Umberto Carnazzi shall thereafter remain out of Nigeria.

This Order may be cited as the Umberto Carnazzi Deportation Order 1980.

**Peter Yung Ling Li Deportation Order 1980**

*Commencement : 20th January 1980*

I, the Minister for Internal Affairs, being of opinion that Peter Yung Ling Li at present in Nigeria ought to be classified as a prohibited immigrant, and acting under the powers conferred by section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said Peter Yung Ling Li be so classified and further order that the said Peter Yung Ling Li be deported from Nigeria by the first available means and I direct that the said Peter Yung Ling Li shall thereafter remain out of Nigeria.

This Order may be cited as the Peter Yung Ling Li Deportation Order 1980.
