AN ACT TO MAKE PROVISION FOR THE RECONSTITUTION OF THE MEMBER-SHIP OF THE ELEVEN RIVER BASINS DEVELOPMENT AUTHORITIES IN NIGERIA.

[1st October 1981]

BE IT ENACTED by the National Assembly of the Federation of Nigeria and by authority of same as follows :---

1. The River Basins Development Authority Act 1979 is hereby amended as follows :---

(a) for subsections (1) and (2) of section 2 thereof there shall be substituted the following new subsection, that is—

"Membership. 2.—(1) Each Authority shall consist of 15 members appointed by the President one of whom shall be appointed as the Chairman of the Authority with the proviso that such a Chairman shall be an indigene of the State or States within which the authority is established as follows :—

(a) in respect of the Sokoto-Rima River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation;

(ii) three persons appointed by the Sokoto State Government;

(iii) three persons appointed by the Kaduna State Government;

(b) in respect of the Hadejia-Jama'are River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation;

(ii) three persons appointed by the Government of Kano State;

(iii) three persons appointed by the Government of Bauchi State ;

(c) in respect of the Chad Basin Development Authority-

(*ii*) three persons appointed by the Government of Borno State ;

(iii) three persons appointed by the Government of Gongola State;

(d) in respect of the Upper Benue River Basin Development Authority—

(ii) three persons appointed by the Government of the Gongola State;

(iii) three persons appointed by the Government of Bauchi State;

(e) in respect of the Lower Benue River Basins Development Authority—

(i) nine persons appointed by the Government of the Fedration;

(ii) three persons appointed by the Government of Benue State;

(iii) three persons appointed by the Government of Plateau State ;

(f) in respect of the Cross River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation;

(ii) six persons appointed by the Government of Cross River State;

(g) in respect of the Anambra-Imo River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation;

(ii) three persons appointed by the Government of Anambra State;

(iii) three persons appointed by the Government of Imo State;

(h) in respect of the Niger River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation,

(ii) two persons appointed by the Government of Niger State;

(iii) two persons appointed by the Government of Kaduna State;

(iv) two persons appointed by the Government of Kwara State ;

(i) in respect of the Ogun-Oshun River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation;

(*ii*) two persons appointed by the Government of Oyo State ;

(iii) two persons appointed by the Government of Ogun State;

(iv) two persons appointed by the Government of Lagos State ;

(j) in respect of the Benin-Owena River Basin Development Authority—

(i) nine persons appointed by the Government of the Federation;

(ii) three persons appointed by the Government of Bendel State;

(iii) three persons appointed by the Government of Ondo State;

(k) in respect of the Niger Delta Basin Development Authority—

(i) nine persons appointed by the Government of the Federation ;

(ii) six persons appointed by the Government of the Rivers State.

(2) (a) (i) The General Manager of each River Basin Development Authority shall be a member of the Board and shall have no voting rights at Board meetings.

(ii) Members of each Authority who are nominated by both the State and Federal Governments and appointed by the President shall be referred to as 'Members'.

(b) immediately after subsection (2) of section 3 thereof, there shall be added the following new subsection, that is to say—

"(3) Where—

(a) the term of office of members of any Authority has terminated by effluxion of time ; or

(b) the president is satisfied that the Authority in question is not discharging its functions under this Act in a manner conducive to the attainment of its functions.

the President may by order dissolve the Board and within a period not exceeding three months appoint an administrator or a committee of management composed of five members to manage the affairs of the Authority until a new Board is constituted for that Authority". Short title.

3. This Act may be cited as the River Basins Development Authorities (Amendment) Act 1981.

AN ACT TO MAKE PROVISION FOR RECONSTITUTION OF MEMBERSHIP OF THE NIGERIAN SHIPPERS' COUNCIL.

[1st October 1981]

1. For section 2 of the Nigerian Shippers' Council Act 1978, there shall be substituted the following new section, that is-

(ii) the Nigerian Export Merchants Association ; and

(iii) the Manufacturers' Association of Nigeria."



1. For section 2 of the Securities and Exchange Commission Act 1979, there shall be substituted the following new section, that is to say-

"Membership of Commission. 2. The Commission shall consist of the following members that is-

(a) a part-time Chairman, who shall not be a Federal or State public officer, to be appointed by the President ;

(b) eight persons appointed by the President, being persons who by reason of any requisite ability, experience and specialised knowledge, have skills that will be useful and will enable them to make effective contributions to the work of the Commission; and

(c) one representative each of the following bodies, that is—

(i) the Central Bank of Nigeria; and

(ii) the Nigerian Enterprises Promotion Board."

2. This Act may be cited as the Securities and Exchange Commission (Amendment) Act 1981.

AN ACT TO MAKE PROVISION FOR RECONSTITUTION OF MEMBERSHIP OF THE NATIONAL INSURANCE CORPORATION OF NIGERIA.

[1st October 1981]

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria and by authority of same as follows:—

1. The National Insurance Corporation of Nigeria Act 1969 is hereby amended as follows :--

(a) for subsection (2) of section 2 thereof, there shall be substituted the following new subsection, that is—

"(2) The Chairman shall be appointed by the President."

(b) for subsections (1) and (2) of section 3 thereof, there shall be substituted the following new subsection :---

"Composition of the Board of Directors, etc. 2.-(1) The membership of the Board shall comprise-

(a) eight persons who shall not be Federal or State public officers, one of whom shall be appointed as chairman; and

(b) the Managing Director of the Corporation.

(2) Appointments of members of the Board under paragraph (a) of subsection (1) above and of the Chairman, shall be made by the President only after first satisfying himself in respect thereof that the person concerned are persons of integrity, and of good standing in the community from which they are to be drawn. In addition, the President must be satisfied that such persons are in the field of industry, commerce, finance or administration and also have specialised knowledge of the working of an insurance business, so as to be capable of discharging the functions of their office in a manner satisfactory to the President." Commencement.
